

# FIGURING THINGS OUT

We are started the Changing Landscape programme by taking a long hard look at the figures.

Over the summer of 2020 we conducted a survey of over 150 of our farm business clients. We asked about their attitudes to key issues and concerns for the future. Above all, we wanted to understand whether and how our clients were starting to prepare for the forthcoming reduction and ultimate removal of the Basic Payment Scheme subsidy, and what we could do to best support them through that period of change.

The Changing Landscape programme was built on what we learnt from those survey results.

Over the following 6 months, we focused on addressing some of those areas that clients told us were of concern or of interest:

- How can I grow my business?
- How should I go about planning for retirement?
- What is Natural Capital and why is it relevant to me?

We started the Changing Landscape programme by taking a long hard look at the figures, an area that we think is critical to sustaining your business through the loss of BPS and the turbulence of Brexit, as well as to successfully expanding or developing your business.

When we asked our survey respondents whether their business would be profitable today without BPS - 49% said it would not and 31% said it would. A further 20% of respondents said they were not sure whether they would turn a profit without subsidy.


Although there is a lot of uncertainty surrounding farm support, we do know that from 2021 to 2027 BPS is due to be phased out, and from 2028 there will be no direct 'Pillar 1' payments made to farmers in England.

To begin to build a business that can survive the loss of BPS, you must start by knowing what your bottom line would look like without it.

Farm business reviews bring together all these elements, considering a business's structure, assets, and profitability to provide an in-depth assessment of its performance and identify areas for improvement.

For some businesses, they might be the start of a completely new direction, for others they may be an opportunity to identify small changes that can take you in to the top percentile of farms in your sector.
