### Location

Kirkby Stephen 0.80 miles. Penrith 25 miles. Kendal 27 miles. Please note all distances are approximate. Hartley is a small village, located within the Eden Valley. The market town of Kirkby Stephen has a weekly market, post office, auction mart and several shops, pubs, and restaurants. There is both primary and secondary education in Kirkby Stephen.

### Kitchen

Fitted kitchen, with oak base and wall units and worktop, ceramic tiled splashback. Stainless steel sink and drainer. Single glazed timber window. Integrated fridge freezer and dishwasher. Electric oven and hob and cooker hood.

### Living Room

Understair cupboard, and staircase to first floor.

### Bedroom

Double bedroom. Single glazed timber window overlooking road.

### Shower Room

Three-piece bathroom, including toilet, wash hand basin and enclosed shower.

### Outside

To the rear of the property there is a lawned garden and garage.

Electric supply.

### Holding Deposit

Before your application can be fully considered, you will need to pay us a holding deposit equivalent to one weeks' rent for the property you are interested in. Once we have your holding deposit, the necessary paperwork should be completed within 15 days, or such longer period as might be agreed. If at any time during that period you decide not to proceed with the tenancy, then your holding deposit will be retained by our firm. It will be retained by this firm. However, if the Landlord decided not to offer you a tenancy for reasons unconnected with the above then your deposit will be refunded within 7 days. Should you be offered, and you accept a tenancy with our Landlord, then your holding deposit will be credited to the first months' rent due under that tenancy. Where, for whatever reason, your holding deposit is neither refunded nor credited against any rental liability, you will be provided with written reasons for your holding deposit not being repaid within 7 days.

### Terms & Conditions

The property shall be let unfurnished by way of an Assured Shorthold Tenancy for an initial term of 6 months at a rental figure of £575 per calendar month, payable in advance by Direct Debit. In addition, a deposit of £663.00 shall also be payable prior to occupation.

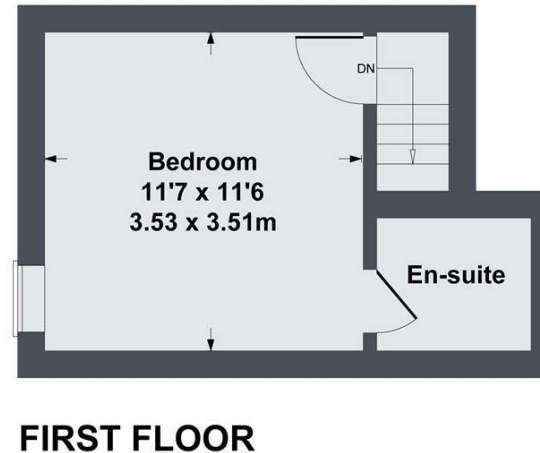

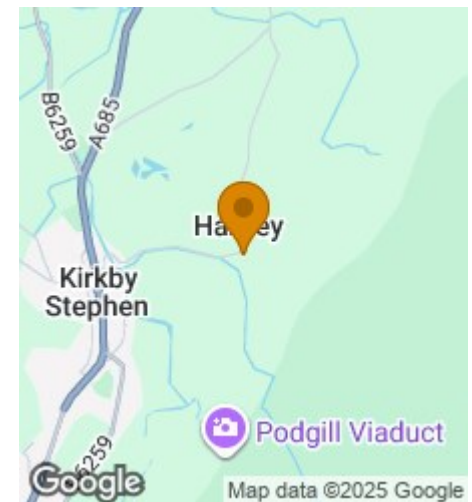


## SKETCH PLAN FOR ILLUSTRATIVE PURPOSES ONLY
