Situated in the historic market town of Barnard Castle, this property provides easy access to the amenities within the town and its surrounding area. There are a number of nurseries, primary and secondary schools in Barnard Castle including Barnard Castle School and Teesdale School. Darlington and Bishop Auckland are both within close proximity, while the cities of Newcastle, Durham, York and Leeds also easily accessible. The property lies within easy reach of the A66 and A1(M) bringing many areas within commuting distance.

### Accommodation

Entrance to former shop/reception area leading to stairs to first floor accommodation and reception room. The reception area provides access to a generous cellar, ideal for storage. At the rear of the property is a commercial kitchen with fixtures and fittings still available plus separate WC. There is also a separate utility space acting as an extension of the kitchen that is accessed externally.

The first floor offers accommodation including two bedrooms, a spacious living room, three piece bathroom with shower and a kitchen overlooking the rear garden. Additionally, there is access to a loft room via ladder.

### Externally

Parking is available on street to the front. The generous rear elevated garden is accessible via a secure alleyway and benefits from a stone built store.

### Auction Terms

This property is for sale by the Modern Method of Auction, meaning the buyer and seller are to Complete within 56 days (the "Reservation Period"). Interested parties personal data will be shared with the Auctioneer (iamsold). If considering buying with a mortgage, inspect and consider the property carefully with your lender before bidding. 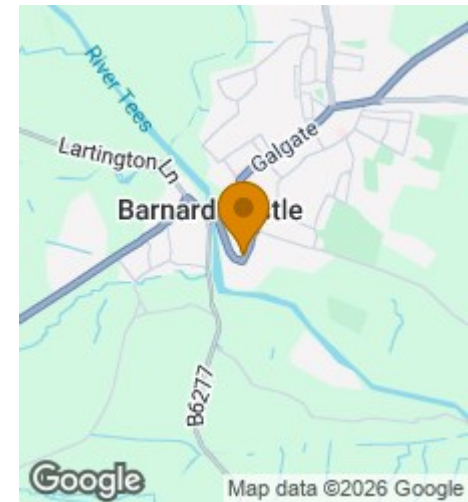
